'Don't back down'

We, the undersigned organizations, welcome the renewed commitment and leadership by over 90 countries to forge a binding global treaty to end plastic pollution to protect human health and the environment. The NICE Declaration reflects a clear majority support for a treaty that addresses the full lifecycle of plastic pollution, building on the growing political momentum that emerged at INC-5.1 in Busan.

The joint Declaration by ambitious countries must be a floor, not a ceiling, and governments must forge a treaty that matches the scale of the plastic crisis, safeguards human rights, and protects generations to come. As a minimum, the treaty – grounded in the knowledge, leadership, and lived realities of frontline communities, workers, waste pickers, and Indigenous Peoples – must not only include measures outlined in their Declaration, but also secure a just transition that protects people and communities in situations of vulnerability around the world.

After more than 2 years of negotiations, Member States, the INC Chair, and UNEP must accept that, to achieve this vision, a treaty adopted by consensus – dictated by the lowest common denominator – is not possible. A few low-ambition States have made every effort to block new measures and prevent a binding global treaty emerging from these negotiations, denying States their right to address this ever-worsening global crisis together. In response, States must now use all available procedural tools, including the option of voting, to conclude these negotiations at INC-5.2 with legally binding obligations and enforceable rules that can provide the certainty needed to reduce global production and shift trade and consumption patterns.

Pollution from across the entire supply chain is degrading ecosystems, contaminating our soils and harming human health and biodiversity. Nearly 30 million tonnes of plastics alone have poured into the oceans since negotiations began in 2022. A global response – anchored in enforceable rules, not vague aspirations – is long overdue. The ambitious majority must translate their strength in numbers into action and prevent a minority of narrow interests from continuing to shift the costs of this crisis on to communities and ecosystems. The upcoming negotiations in Geneva must be a test of will, leadership, and our collective ability to harness effective multilateralism in a shifting geopolitical landscape. The credibility of this process and multilateralism broadly hinges on delivering the treaty that was promised. Anything less would be a betrayal of global trust.

We now call upon other Member States to join the NICE Declaration and demonstrate ambition ahead of and during INC-5.2.
